- **2d** = 16 hrs (instead of 8). Same as 1d, plus evaluation of the intention/willingness to participate as partner or coordinator quick search for previous projects recently approved in your field to avoid being rejected due to lack of novelty, assessment of your company capabilities and capacity in playing selected roles.

The most popular session.

- **3d** = 24 hrs. The activities carried out are fully customised and include, but are not limited to, what described in the 1d and 2d sessions. **Mainly addressed to** clients willing to participate in the EIC Accelerator scheme.
